

PROCEEDING OF THE SPECIAL GENERAL MEETING OF HOCKEY ODISHA - Dt. 9.3.2021 AT BARABATI GUEST HOUSE BARABATI STADIUM, CUTTACK

The meeting commenced with Justice Shri. A.S. Naidu, President of Hockey Odisha on the chair. Confirmation of the minutes of proceedings of previous Annual General Meeting Dt.08.03.2020

The proceedings were already circulated among the members present in the house as proposed by Shri. R. Sanjeeb Rao and seconded by Shri. Pranab Kishore Sarangi. ACTIVITY REPORT OF THE HONORARY GENERAL SECRETARY FOR THE YEAR 2020-2021



Respected President and Members of the House

I warmly welcome our President Hon'ble Justice Shri A.S. Naidu, all office bearers and ex-Officio Members of this august house. It is my immense pleasure and privilege to have you all in this important gathering for the cause of Hockey in the State of Odisha. I hereby like to state that 2020-21 was a period of untold misery, hardship and challenges which gripped the entire globe due to novel coronavirus covid 19. In India we too faced the brunt of the pandemic which not only created havoc in our lives by creating an environment of uncertain future but simultaneously took away precious lives. The pandemic created an uncertain impact on the sporting activities. On behalf of Hockey Odisha with profound grief I hereby pay my homage to those myriads that lost their precious lives due to the dreaded Covid 19 pandemic. I request the house to please stand in silence for two minutes and to pray the almighty for the departed souls to rest in eternal peace.

ACHIEVEMENTS OF HOCKEY ODISHA 2021

As the pandemic started to spread rapidly from March 2020 onwards, therefore there was no national championships conducted during the entire period, even in the last two consecutive years Hockey Odisha did not conducted NALCO Cup State Hockey Championship for men and women. The only exception was the 11th Hockey India Sub Junior Men National Championship 2021 which was held at Narwana, Jind in the State of Haryana from 17th March to 23rd March 2021. The said Championship was played on a grass field. Hockey Odisha Sub Junior men team was qualified for quarter final.

11th Hockey India Sub Junior Women National Championship 2021 was held at Simdega in the State of Jharkhand from 10th March to 18th March 2021. Hockey Odisha Sub Junior Women team stood 4th position in the National Championships 2021.

If further take the opportunity to inform the august house due to illegal and in arbitrary manner by which Hockey India formed an ADHOC Committee against Hockey Odisha, ignoring the basic principle of natural justice; a writ petition has been filed against Hockey India in the Hon'ble High Court of Orissa. The single bench of Justice Shri. Biswanath Rath observed that "Since the effect of Annexure-1 has already come into play, this court is not inclined to grant interim order at this stage. This court however observes suffering if any to the petitioner (Hockey Odisha) pursuant to

In another interim stay order of the Hon'ble Orissa High Court; our Vice President Shri Umakanta Nanda filed a writ petition which challenged the letter issued by Hockey India on January 29th of 2018, fixing the age limit of all elected office bearers and board members of each of its affiliated units to below 70 years. Our Vice President also sought quashing of the letter from Hockey India, issued on March 24th of 2021 addressed to the President and General Secretary of Hockey Odisha giving 30 days final notice to submit the details and to comply with requirements mentioned therein in order to continue as associate member of Hockey India.

The single judge bench of Hon'ble Justice Dr. B.R.Sarangi said the matter requires consideration, saying, "The action taken by the Hockey India putting restriction with regard to the age limit of the members of Hockey Odisha may not have justification in view of their own by-laws and rules governing the field. As an interim measure, it is directed that there shall be stay on operation of letters dated 29.01.2018 and 24.03.2021."

I hereby like to point out that the letter dated 29.01.2018 of Hockey India which exclusively spelt out of age limit to be below 70 years and another letter dated 24.03.2021 of Hockey India which laid down series of demands to be fulfilled within 30 days from the date of issue of the letter or else an ADHOC Committee shall be formed has been given stay order by the Hon'ble High Court of Orissa. As per the Central government prerequisite about age factor, it is not binding to the State Sporting Associations which is governed by its own by-laws.

Hon'ble Justice Dr. B.R.Sarangi has fixed August 28th 2021 as next date while issuing notice to Hockey India and the Central government to file their responses.

"The fixation of 70 years age limit is applicable only to Hockey India as per the Hockey India Constitution as its speaks nothing about fixation of age limit either for members of the associate members or any other elected members of such associate members. If the restriction has been imposed for Hockey India that cannot be thrust upon the Hockey Odisha." As stated in the interim order.

Thereby also like to state to the august house that Hockey Odisha have written a memorandum to the Hon'ble Chief Minister Shri Naveen Patnaik to intervene and advice in response to a letter issued by the former Principal Secretary, Department of Sports and Youth Affairs, Government of Odisha, by which a direction has been issued to the Chairman of the newly constituted ADHOC Committee of Hockey sports by Hockey India to communicate to the District Collector of all the 30 districts to form District Hockey Association. As per the letter the District Collector shall function as Ex-Officio President of the District Hockey Association. In this regard the District Collector shall

nominate one senior officer to function as the Ex-Officio Secretary and the District Sports Officer as Treasurer of the District Association in all the 30 districts of Odisha. In our memorandum we have brought to the notice of our Hon'ble Chief Minister that Hockey Odisha has been kept in dark and there was no such attempt by the Department of Sports and Youth Affairs to take us into confidence before issuing such direction. This is a violation of the International Olympic Charter and also a violation to engage government officials to manage ADHOC Committee of Hockey sports formed by Hockey India without consultation with Hockey Odisha. We have highlighted in our memorandum that by ignoring Hockey Odisha it is clear that an attempt to incapacitate a duly elected autonomous sporting association thereby a precedent is being made that such trend can be applied to other sporting bodies too.

Last not the least that I want to conclude my report in a joyful note that Hockey Odisha is proud of the unparalleled achievement of our Hockey team of both men and women in Tokyo Olympics. Hockey Odisha extend its deep appreciation and congratulate our four players Amit Rohidas, Birendra Lakra, Deep Grace Ekka and Namita Toppo who were part of our Hockey contingent to Tokyo Olympics. I on behalf of Hockey Odisha thank our Hon'ble Chief Minister Shri Naveen Patnaik for being the mentor of Indian Hockey Team and the government being very supportive and sponsoring both Indian men's and women's teams since 2018. I like to emphasis here that Hockey Odisha has been vocal in regard to the expansion of more synthetic turfs in other districts of Odisha which has potential. It is high time that districts like Cuttack, Sambalpur, Ganjam, Deogarh, Dhenkanal, along with other districts and so on should be provided with synthetic hockey turfs and Hockey hostels. If such facilities are provided I am sure the game of Hockey in Odisha shall take us to the next level of excellence in our country.

I thank you all for your kind participation and support to the cause of Hockey in Odisha. Jay Hind
